Press Release

Date November 8th 2019

At approximately 9:30 AM on November 7th 2019, Uniformed Officers of the Fall River Police Department were dispatched to a Division Street residence in response to a *House Break in Progress*. On arrival, Officers spoke to the 58 year old resident who stated he and his 28 year old son were home when the front door to the apartment was kicked in, a male and female entered, and upon seeing the resident and his son, both fled, running to a waiting black Ford F-150 occupied by another male. The father and son were able to give detailed descriptions of the suspects.

Shortly after the description was broadcast to other patrolling unit, the F-150 was spotted speeding east on Mount Hope Avenue from Bay Street operated by the female and was subsequently stopped by Officer Keith Pires and Christopher Rocha. All three suspects were positively identified by the victims and taken into custody.

Bullet casings were observed on the floorboard of the F-150. The F-150 was impounded; Officer Morin applied for and received a search warrant on November 8th. During the search of the truck, a loaded Smith & Wesson 9mm handgun was located under the front passenger seat.
