**Press release**

On April 13<sup>th</sup> 2020, Fall River Police Officer David DelValle responded to K&S Laundromat on South Main Street in response to a lethal weapon call. Officers Tyler Paquette, Eric Pacheco, David Medeiros, and Street Supervisor Brian Cabral responded to assist. Officers learned a 41-year-old male from the State of Washington was approached by Luis Negrón, who was brandishing a firearm. Negrón accused him of having an affair with his girlfriend while pointing the gun at him. Negrón demanded the victim get into the disabled vehicle that was being repaired. When the victim refused, Negrón got in and attempted to take that vehicle but the vehicle would not start. Negrón fled the area in a vehicle operated by a female. Witnesses were able to get a registration number and gave it to Officer DelValle.

Officers responded to the registered owners Ridge Street address where they located the truck and the female driver. Officers were allowed entry into the residence by that female to search for Negrón. During that search Officers located two rooms on the second level with numerous Marijuana plants. Because of that discovery, Officers requested and received a Search Warrant for the premises. During that search, Officer Zachery Dupere located Negrón hiding in the basement. Negrón refused to submit to commands and fought with Dupere by grabbing his firearm. Officers Chelsea Campellone and DelValle assisted in the struggle to take Negrón into custody but he continued to kick and resist before being subdued and taken into custody.

Luis Negrón dob 12/20/1978 age 41 of 559 Ridge Street Fall River was charged with:

- Carjacking w/Firearm
- Assault Dangerous Weapon
- Attempt to Commit a Crime
- A&B to Disarm a Police Officer
- Assault with a Dangerous Weapon
- A&B on a police officer
- Cultivating Class D Marijuana

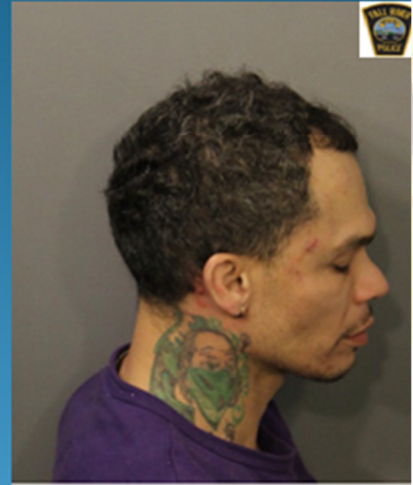
- Carry Firearm w/o LTC

Luis Negrón age 41 was located hiding in the basement. When located by Officers of the FRPD Uniform Division who were executing a search warrant, Negrón fought with officers, grabbing hold of an officers firearm before being taken to the ground. During the struggle, Negrón continued to kick and resist before being subdued. Earlier in the day, Negrón approached a 41-year-old male while brandishing a firearm and accused him of having an affair with his girlfriend. Officers located 99 Marihuana plants during the search.
